JUDGEMENT OF AFFIRMATION AND RECOGNITION OF GENDER

On this 20th day of May, 2013, the Petition of JAMIE MIRANDA GLISTENBURG, for Gender Recognition comes on to be heard, and after fully examining said Petitioner with medical verification, as to the reason for said desired affirmation and recognition of gender, it is found that said request of relief is proper and that such change will not be detrimental to the interest of any persons, nor be against the interest of the state or of any given establishment.

WHEREFORE, this court order seeks to create uniformity in all documents and data bases that require a declaration of the Petitioner's gender. MOREOVER, this order shall fully satisfy any given prerequisite or mandate pertaining to gender declaration, affirmation, change, or amendment.

Let it be therefore ORDERED, ADJUDGED, and DECREED, that the gender of the said petitioner JAMIE MIRANDA GLISTENBURG be hereby affirmed and recognized as FEMALE by order of the CIRCUIT COURT OF ADAIR COUNTY; that such in regard to all previous, current, and future documents, including other materials requiring a declaration of gender in legal standing, be given privilege and right standing per request of said gender as afforded by full faith and credit.


Let it therefore be firmly ORDERED, pursuant to the power of this court, that the SOCIAL SECURITY ADMINISTRATION and all other establishments or institutions not mentioned herein requiring declaration of gender, upon receipt of appropriate fees, adhere to the following:

1. If the gender marker of the Petitioner has not already been changed by virtue of recognition as ordered in CASE NO. 13AR-CV00157 concerning the MISSOURI DEPARTMENT OF REVENUE, the establishment or institution in question shall AMEND, ESTABLISH, or formally RECOGNIZE the gender of the Petitioner JAMIE MIRANDA GLISTENBURG as being FEMALE.

WHEREFORE, the court understands that select circumstances, such as this case, require judicial intervention in order to prevent discrimination. MOREOVER, the explicit requirement of surgical procedures or medications that may be deemed unsuitable, dangerous, or unnecessary to the Petitioner by medical assertion shall be given relief notwithstanding Mo. Ann. Stat. § 193.215(9).

Let it therefore be firmly ORDERED, that the MISSOURI DEPARTMENT OF HEALTH AND SENIOR SERVICES BUREAU OF VITAL RECORDS, upon receipt of appropriate fees, make the following changes:

1. AMEND the BIRTH CERTIFICATE to reflect the gender as FEMALE.
2. AMEND and CONSOLIDATE the BIRTH RECORD of said Petitioner; that the Petitioner's BIRTH CERTIFICATE show, without duplication or strikethrough, only ONE AMENDMENT instead of many upon the issued certificate.
3. A note of formal amendment may be inserted into the private record of the Petitioner if it pleases the Bureau.
