**JUDGEMENT OF NAME CHANGE
WITH AMENDMENTS**

On this 22nd day of April, 2013, the Petition of JAMES MARION STRISEMBVEK, for Change of Name with Amendments comes on to be heard, and after fully examining said Petitioner, as to the reason for said desired name change, it is found that said name change with amendments is proper and that such change will not be detrimental to the interest of any persons, nor be in violation of proprietary interests of any given establishment.


Let it be therefore ORDERED, ADJUDGED, and DECREED, that the name of the said petitioner JAMES MARION STRISEMBVEK be hereby LEGALLY changed to JAMIE MIRANDA GLISTENBURG by order of the CIRCUIT COURT OF ADAIR COUNTY; that such in regard to all previous, current, and future documents – including other materials requiring a name of legal standing – be given privilege and right standing per request of change and/or establishment of said name.

Let it therefore be firmly ORDERED that the MISSOURI DEPARTMENT OF REVENUE, upon receipt of appropriate fees, make the following changes:

1. AMEND the name to read JAMIE MIRANDA GLISTENBURG with corresponding gender marker shown as FEMALE.

Let it therefore be firmly ORDERED, that the MISSOURI DEPARTMENT OF HEALTH AND SENIOR SERVICES BUREAU OF VITAL RECORDS, upon receipt of appropriate fees, make the following changes:

1. AMEND the name to read JAMIE MIRANDA GLISTENBURG.
2. AMEND and CONSOLIDATE the BIRTH RECORD of said Petitioner; that the Petitioner's BIRTH CERTIFICATE show, without duplication or strikethrough, only ONE AMENDMENT instead of many upon the issued certificate.
3. A note of formal amendment may be inserted into the private record of the Petitioner if it pleases the Bureau.
4. The BUREAU OF VITAL RECORDS shall not amend gender marker at this time until a future and separate order is issued by the Court for said Petitioner.
